PETITION

on the clarification of all sorts of doubts and uncertainties arising from the execution of the sentence

On June 22, 2020, by an unconstitutional (unlawful) judgment of the Medeu District Court No. 2 of the city of Almaty (No. 7525-20-00-1/174, hereinafter – "Judgment") in violation of the international obligations of the Republic of Kazakhstan, in favor of the leadership of the party "Nur Otan", I, A. K. Ilyashev, was found guilty of committing a crime under Article 274 Part 4 Paragraph 2 of the Criminal Code of the Republic of Kazakhstan, and sentenced to 3 (three) years probation and one hundred hours of forced labor per year throughout the entire term of probation.

In addition, A. K. Ilyashev was sentenced to *additional punishment in the form of* <u>deprivation of the right to engage in</u> civil and <u>public activities aimed at voluntarily serving</u> the political, <u>cultural</u>, and professional <u>needs of society</u>, to create and partake in the activities of political parties, public associations and foundations for a period of 5 (five) years (page 14, paragraph 6 of the "Judgment").

Judge Z. I. Makharadze's secretary recommended contacting the probation authorities for clarification. But the Medeu District Probation Service Office of the Penal Correction Department for the city of Almaty and the Prosecutor's Office of the Medeu District (through the Prosecutor's Office of the city of Almaty) could not provide an intelligible answer to the corresponding request and just cited a paragraph of the resolutive part of the "Judgment," eventually redirecting me to the court.

Considering the above and being guided by Articles 476-478 of the Criminal Procedure Code of the Republic of Kazakhstan, Article 50 of the Criminal Code of the Republic of Kazakhstan and Article 72 of the Penal Code of the Republic of Kazakhstan, **I ask you to clarify if in this regard IT IS FORBIDDEN FOR ME, Ilyashev Alnur Kairatovich, TO PUBLICLY:**

- recite poetry and other <u>literary</u> works;
- participate in <u>theatrical</u> and other stage performances, in shooting of television and video films, and <u>cinema movies</u>;
- write and publish my own literary works (stories, novellas, memoirs, children's fairy tales, pamphlets, etc.);
- vocally and/or instrumentally perform <u>musical</u> works;
- <u>engage in enhancing the citizens' culture</u>, including through pedagogical activities in the field of education;
- <u>other forms of citizens' public expression in the field of culture or cultural behavior in public.</u>
